OBRAZLOŽENJE

Na temelju članka 51. Zakona o trgovini («Narodne novine» br. 87/08 i 116/08), Vlada Republike Hrvatske donijela je Uredbu o nadzoru uvoza i izvoza neobrađenih dijamanata («Narodne novine» br. 97/03, 142/03, 176/04, 14/06, 90/07 i 64/08), kojom se propisuju uvjeti i nadzor uvoza i izvoza neobrađenih dijamanata radi provođenja postupka certificiranja Procesu Kimberley.

Republika Hrvatska, kao sudionica Procesu Kimberley obvezna je uskladiti Uredbu s novim popisom zemalja sudionica Procesu Kimberley.

Prijedlogom Uredbe o izmjeni Uredbe o nadzoru uvoza i izvoza neobrađenih dijamanata ažurira se popis zemalja sudionica Procesu Kimberley.

Republika Meksiko postala je nova sudionica Procesu Kimberley, a Republika Cote d'Ivoire skinuta je s popisa zemalja sudionica s obzirom da se nalazi pod sankcijama UN-a. Republika Venezuela skinuta je s popisa sudionica slijedom dobrovoljnog istupanja Venezuele iz članstva u Procesu Kimberley.

Također, unijete su izmjene vezane uz nazive i sjedišta nadležnih tijela zaduženih za Proces Kimberley u određenim zemljama sudionicama.

Predlaže se Vladi donošenje Uredbe radi ispunjavanja međunarodno preuzete obveze vezane uz nadzor međunarodne trgovine neobrađenim dijamentima.
