Zakona o Vladi Republike Hrvatske (Narodne novine, br. 101/98, 15/2000, 117/2001, 199/2003 i 30/2004), a u vezi sa člancima 4.a, 4.b i 4.c Odluke o načinu prodaje, cijeni, vremenu i uvjetima prodaje dionica INA – Industrije nafte d.d. javnom ponudom i posebnim pogodnostima prodaje hrvatskim građanima (Narodne novine, br. 104/2006, 113/2006 i 122/2006), Vlada Republike Hrvatske je na sjednici održanoj 27. studenoga 2006. godine donijela

ODLUKU

o davanju suglasnosti na Prijedlog okvirnog rasporeda dionica u postupku privatizacije INA – Industrije nafte d.d.

I.

za kupnju dionica INA – Industrija nafte d.d.

1. Javna ponuda odnosi se na ne više od 1.700.000 (17 %) i ne manje od 1.500.000 (15%) dionica INA – Industrija nafte d.d.
2. Hrvatski građani su u povlaštenoj ponudi (sa pravom prvenstva i posebnim pogodnostima) uplatili ukupno - 895.633 dionice.
3. Za dopunske dionice rezervirano je, a sukladno uvjetima povlaštene ponude, ukupno – 80.368 dionica.
4. U nepovlaštenoj ponudi (obvezujućoj i indikativnoj) ostalo je neraspoređeno ukupno – 723.999 dionica, koje je potrebno rasporediti na ponuditelje – hrvatske građane bez prava prvenstva i posebnih pogodnosti, domaće pravne osobe i strane ulagatelje, koji su podnijeli obvezujuću ili indikativnu ponudu.

II.
Prijedlog o okvirnom rasporedu na ponuditelje

U nepovlaštenoj ponudi ostalo je neraspoređeno ukupno – 723.999 dionica, koje je potrebno rasporediti na ponuditelje – hrvatske građane bez prava prvenstva i posebnih pogodnosti, domaće pravne osobe i strane ulagatelje, koji su podnijeli obvezujuću ili indikativnu ponudu.


Prospektom INA – Industrija nafte d.d., Zagreb te Odlukom o načinu prodaje, cijeni, vremenu i uvjetima prodaje dionica INA – Industrija nafte d.d. javnom ponudom i posebnim pogodnostima prodaje hrvatskim građanima (Narodne novine, broj 104/2006, 113/2006, 122/2006), za određivanja rasporeda dionica na ponuditelje, i to fizičke osobe koje su predale obvezujuću ponudu, te domaće pravne osobe i strane ulagatelje, koje su predale indikativnu ponudu, predviđena je primjena diskrecione ocjene za prihvaćanje obvezujuće i indikativne ponude.

1. Ukupan broj neraspoređenih dionica u nepovlaštenoj (obvezujućoj i indikativnoj) ponudi predlaže se podijeliti između hrvatskih građana, bez prava prvenstva i posebnih pogodnosti i domaćih pravnih osoba te stranih ulagatelja u omjeru - 35%:65%, i to tako da se hrvatskim građanima i fizičkim osobama, koji su predali valjanu, obvezujuću ponudu bez prava prvenstva i posebne pogodnosti, prihvate ponude do maksimalnog iznosa od - 30.000 kn (17 dionica), temeljem čega bi se navedenim fizičkim osobama rasporedilo ukupno – 9.042 dionice; ostatak dionica bi se raspodijelio između domaćih pravnih osoba i stranih ulagatelja, koji su podnijeli indikativnu ponudu.
2. Za raspored dionica na domaće pravne osobe i strane ulagatelje koji su podnijeli indikativnu ponudu, predlaže se, osim primjene diskrecione ocjene ponuda, primjena i slijedećih objektivnih kriterija:
 - a. Ponuditelji su podijeljeni u 2 kategorije: ponuditelji kojima je jedna od osnovnih djelatnosti ulaganje u vrijednosne papire, uključujući i investicijske fondove (otvorene, zatvorene, obvezne mirovinske i dobrovoljne mirovinske) i ponuditelji kojima osnovna djelatnost nije ulaganje u vrijednosne papire;
 - b. Ponuditelji kojima je jedna od osnovnih djelatnosti ulaganje u vrijednosne papire podijeljene su u sljedeće kategorije: obvezni mirovinski fondovi, dobrovoljni mirovinski fondovi, dionički i mješoviti investicijski fondovi, obveznički investicijski fondovi, banke i brokerske kuće, društva za upravljanje investicijskim fondovima i osiguravajuća društva;
 - c. Najveći dio dionica predlaže se rasporediti obveznim mirovinskim fondovima, pri čemu je prijedlog raspodjele izvršen prema veličini fonda i primjenom diskrecijskih ovlaštenja;
 - d. Dioničkim i mješovitim investicijskim fondovima predlaže se rasporediti više dionica nego obvezničkim investicijskim fondovima, pri čemu je prijedlog raspodjele izvršen prema veličini fonda i primjenom diskrecijskih ovlaštenja;
 - e. Između dobrovoljnih mirovinskih fondova prijedlog raspodjele izvršen je prema veličini i primjenom diskrecijskih ovlaštenja fonda;
 - f. Kod banaka i financijskih institucija, kao i kod osiguravajućih društva primijenjen je kriterij limita iznosa ponude, dok je daljnja predložena raspodjela izvršena prema veličini financijske institucije i njenom udjelu na tržištu kapitala te primjenom diskrecijskih ovlaštenja;
 - g. Ostali ponuditelji kojima je jedna od osnovnih djelatnosti ulaganje u vrijednosne papire ocjenjuju se primjenom diskrecijskih ovlaštenja;
 - h. Ponude ponuditelja kojima osnovna djelatnost nije ulaganje u vrijednosne papire predlažu se, prema diskrecijskoj ocjeni, ne prihvatiti ili djelomično prihvatiti te sukladno takvoj odluci, takvim ponuditeljima kojima ponuda nije niti djelomično prihvaćena, ne rasporediti dionice.

Ovom Izvješću priložen je popis fizičkih osoba koje su predali obvezujuću ponudu (bez prava prvenstva i posebnih pogodnosti) te domaćih pravnih osoba i stranih ulagatelja koji su predali indikativnu ponudu. Navedenim popisom naznačen je iznos ponude svakog pojedinog ponuditelja, prijedlog iznosa prihvaćene ponude i raspodjele dionica te naznaka iznosa koji bi se imao vratiti ponuditeljima u slučaju cjelovitog ili djelomičnog odbijanja ponude.
